**Background** (see also H2N Relevant Contribution and H2N Context Analysis)

SDC mandate is to make a relevant contribution to the improvement of the living conditions, the reduction of causes of conflicts and the increase of the crisis resistance in selected fragile contexts and to enhance enjoyment of human rights.

OECD (State of Fragility Report 2015) assesses "fragility as an issue of universal character that can affect all countries, not only those traditionally considered "fragile" or conflict-affected."

Linking the Peace and Statebuilding Goals of the New Deal with the Sustainability Goal 16, the following patters are identified for fragility:

- Accountable and effective and transparent institutions for legitimate politics and service delivery;
- Reduction of violence and fostering accountability for strengthening peoples security;
- · Access to justice for better rule of law;
- Economic inclusion and stability for livelihoods, jobs and public service delivery;
- Capacities to prevent and adapt to social, economic and environmental shocks and disasters in order to build resilient state society and inter societal relationships to withstand violence.


